G.S:R - In exercise of the power conferred by the proviso to article 309 of the Constitution and in supersession of the Ministry of Home Affairs (Department of Administrative Reforms) Recruitment Rules, 1969, in so far as they relate to the post of Research Assistant, except as respects things done or omitted to be done before such supersession the President hereby makes the following rules regulating the method of the post of Research Assistant in the Ministry of Personnel, Public Grievances and Pensions. Department of Administrative Reforms and Public Grievances. Namely:-

- Short title and commencement: (1). These rules may be called the Ministry of Personnel Public Grievances and Pensions, Department of Administrative Reforms and Public Grievances. Research Assistant Group 'B' Post Recruitment Rules 2003.
 - (2) They shall come into force on the date their publication in the Official Gazette.
- Number of post classification and scale of pay:-The number of post, its classification and scale of pay attached there to shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
- Method of recruitment, age limit, qualifications, etc:- The method of recruitment, age limit, qualifications and other matters relating to the post shall be as specified in columns 5 to 14 of the said Schedule.
- 4 Disqualifications:- No Person
 - (a) Who has entered into or contracted a marriage with a person having a spouse living or
 - (b) Who, having a spouse living has entered into or contracted a marriage with any person,

Shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- Power to relax: Where the Central Government is to the opinion that it is necessary or expedient so to do, it may by an order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6 Saving:- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribles, ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time in this regards.
