1. Key Highlights

1. General

- Meeting with DGs and Nodal Officers of the ATIs of all the States/UTs was held on 5th January, 2023. A total of 20 proposals has been received under the Sevottam scheme out of which grants for 14 States/UTs have been released and for 6 States/UTs, the proposals are under process
- ATIs which have received Sevottam grant for FY 2022-23 provided the progress:
 - Haryana Institute of Public Administration has conducted 20 training programmes wherein 718 officers participated
 - HCM Rajasthan State Institute of Public Administration has conducted 25 training programmes wherein 600 officers were trained
 - Uttar Pradesh Academy of Administration and Management has completed 17 training programmes wherein 205 officers were trained
 - Mahatma Gandhi State Institute of Public Administration, Punjab has conducted 16 training programmes wherein 425 officers were trained
 - RCVP Noronha Academy of Administration and Management, Madhya Pradesh has conducted Trainer of Trainers programmes to train 31 master trainers
 - Sri Krishna Institute of Public Administration, Jharkhand has conducted 9 out of the proposed training programmes
- The other ATIs were requested to indicate their plans for submission of the Sevottam proposal for FY 2022-23 and 2023-24
- Meeting with Grievance Redressal Officers of the States/UTs was held on 4th January, 2023, to review the pendency and disposal of public grievances on CPGRAMS and progress of State/UT portals with CPGRAMS
- Nodal Officers were requested to have regular meetings with GROs to expedite redressal and improve average closing time
- Pending forward integration of State PG portals with CPGRAMS for West Bengal and Tamil Nadu, and reverse integration for Bihar, Kerala, Tamil Nadu and West Bengal to be expeditiously completed
- Nodal Officers may review mapping of GROs on CPGRAMS and consider increasing mapped GROs

2. PG Cases

- In January, 2023, **53292 PG cases** were received for the States/UTs and **42517 PG cases** were redressed
- For States/UTs, as on 24th January 2023, there exists a pendency of **197795 PG cases**
- The pendency in the States/UTs has increased from **187020 PG cases at the end of December, 2022** to **197795 PG cases at the end of January, 2023**
- **Government of Uttar Pradesh** has received the maximum number of grievances in January, 2023 with the number standing at **16575** grievances
- **Government of Uttar Pradesh** has disposed the maximum number of grievances in January, 2023 with the number standing at **12503** grievances

3. Pendency

- **21 States/UTs** have more than 1000 pending grievances as on 24th January, 2023
- **Government of Maharashtra** has the maximum number of pending grievances (overall and pending for more than 30 days) with the number standing at **24929 grievances** (overall) and **21563 grievances** (pending for more than 30 days)


4. PG Officers

- **33695 PG Officers** from States/UTs are mapped onto the CPGRAMS Portal
- **Government of Haryana** has the highest number of PG officers mapped onto CPGRAMS with **7406 PG Officers** mapped

5. Average Closing Time

- **28 States/UTs** have their Average Closing Time of grievances more than the Standard Redressal Time of 30 days





4. Performance of States/UTs

- For States/UTs, till 24th January, 2023, a total of 53292 grievances have been received with additional 187020 grievances being brought forward from the year 2022, 42517 grievances have been disposed of while 197795 grievances are still pending disposal
- For the month of January, 2023, the Government of Uttar Pradesh has received the maximum number of grievances with the state receiving 16575 grievances, followed by the Government of Assam at 2nd place, with the number standing at 4217 registrations. The Government of Gujarat with 3747 receipts in January, completes the Top 3 positions
- Government of Jharkhand recorded 2441 grievances in the month of January, thus placing it 8th in the list, with the Top 10 being closed by the Government of Haryana which has received 2073 grievances
- In the month of January, 2023, the Government of Uttar Pradesh has disposed of the maximum number of grievances (12503) followed by the Government of Assam disposing of 4640 grievances
- Government of Maharashtra with a pendency of 24929 grievances tops the list of States/UTs with the highest pendency, the Government of Punjab with a pendency of 16685 grievances stands at the 5th position, and the Government of Madhya Pradesh with a pendency of 8144 grievances stands at the 9th position
- As of 24th January, 2023, only the Government of Maharashtra has more than 20,000 pending grievances, while 7 States have more than 10,000 pending grievances
- Government of Bihar has the 2nd highest pending grievances for more than 30 days with the number standing at 15870 grievances

5. Average Closing Time of Grievances

- 28 States/UTs have an Average Closing Time greater than the Standard Redressal Time of 30 days
- Government of Tripura has the highest Average Closing Time of 180 days (against 406 disposals), followed by the Government of Punjab standing at the 2nd position with an Average Closing Time of 158 days (against 1193 disposals). The Government of Himachal Pradesh averaging 117 days (against 184 disposals) closes out the Top 5 list, whereas the Government of Puducherry taking an average of 91 days to close out a grievance (against 98 disposals) stands at the 9th position, the Government of Union Territory of Chandigarh

recorded an average of 87 days (against 154 disposals) stands at the 10th position

- Government of Jammu & Kashmir with Average Closing time of 8 days (against 6 disposals) tops the list of States/UTs with lowest Average Closing Time, followed by the Government of Manipur at the 2nd position which averaged 13 days (against 1 disposal) and the Government of Telangana at the 3rd position, registering an Average Closing Time of 15 days (against 245 disposals)
- Government of Meghalaya stands at the 4th place with an Average Closing Time of 15 days (against 55 disposals), the Government of West Bengal standing at the 5th place, with an Average Closing Time of 19 days (against 15 disposals), and the Government of Uttar Pradesh averaging 28 days (against 12503 disposals) stands at the 7th place

6. Public Grievance Officers

- Numbers of PG Officers mapped onto CPGRAMS in January have increased on the back of massive reforms activity undertaken by the Department of Administrative Reforms and Public Grievances
- Number of PG officers mapped onto CPGRAMS for States/UTs stands at 33695 officers
- Government of Haryana has the maximum number of mappings with the figure standing at 7406 officers, followed by the Government of Maharashtra which has mapped 4984 officers, and the Government of Gujarat standing at the 3rd place with 4679 mappings
- The Top 10 list is closed by the Government of Tamil Nadu and the Government of Bihar with the former securing 9th place with 1359 mappings, and the latter standing at the 10th position with 1069 officers mapped onto the CPGRAMS

7. Integration of State/UT Portals with CPGRAMS

- Under the One Nation-One Portal vision, the Department of Administrative Reforms and Public Grievances has undertaken a massive mandate of linking all the respective State/UT portals with CPGRAMS
- 18 States/UTs do not use a separate dedicated public grievance portal and instead leverage the CPGRAMS interface entirely, to resolve citizen's grievances
- Of the remaining 18 States/UTs which have dedicated public grievance portals, 2 States namely Tamil Nadu and West Bengal are pending with Forward Integration with CPGRAMS, which means the grievances received on CPGRAMS pertaining to the 2 States

cannot be pushed to/consumed by the State portals

- 4 States with dedicated public grievance portals, namely Bihar, Kerala, Tamil Nadu and West Bengal are pending with Reverse Integration with CPGRAMS, which means that the grievances received by these State portals cannot be pushed to/consumed by CPGRAMS
- Kerala, Rajasthan and West Bengal are the 3 States which still do not feature the CPGRAMS link on their state portal to enable the re-direction of the citizen

8. Status update of the proposals for Sevottam received from States/UTs

- In a major capacity building effort, the Department of Administrative Reforms & Public Grievances has launched a major scheme “Sevottam”, under which the Department Funds State ATIs/CTIs, for setting up of a Sevottam Training cell in the ATI for capacity building of grievance redressal officers
- DARPG vide D.O. letter dated 15.06.2022 and 02.12.2022 from the Secretary (AR&PG) has requested all the remaining States/UTs for sending their proposal for Sevottam
- Under the scheme, there is a provision for a lump-sum grant of up to Rs. 20 lakhs per year to each of the State ATIs/CTIs, and the Department has requested the States/UTs for self-contained proposals regarding the same
- Grants to 14 States namely Haryana, Punjab, Uttar Pradesh, Jharkhand, Madhya Pradesh, Rajasthan, Meghalaya, West Bengal, Maharashtra, Gujarat, Andhra Pradesh, Telangana, Tamil Nadu and Himachal Pradesh have been released
- The proposals of 7 States namely Goa, Karnataka, Tripura, Mizoram, Kerala, Jammu & Kashmir and Odisha are under process

9. Analytics by CPGRAMS Data Strategy Unit (DSU)

Department of Administrative Reforms and Public Grievances has set up a Data Strategy Unit w.e.f. from March, 2022. DSU has developed an analytical dashboard that may be used for strategic decision making and policy-reforms for seamless delivery of services to the citizens. The dashboard provides GROs data analysis, trend analysis, geographical analysis, root cause analysis for all the Central Ministries/Departments and States/UTs.

Habitual Complainants:

DSU has identified habitual complainants who have filed thousands of grievances and appeals, thereby choking the system. These grievances create difficulties for the Grievance Redressal Officers in identifying genuine critical grievances.

Mr. Anand Thakur has filed 37,315 grievances, the maximum by a single person, followed by Mr. Atin Maity at the 2nd position who has registered 16199 grievances from *1st January, 2022 to 25th December, 2022*. While, Mr. Suneet Kapur has filed 7,401 appeals, followed by Mr. Jayesh Kulkarni who has filed 5,426 appeals from *1st January, 2022 to 17th November, 2022*.

ORDER

Sanction of the Competent Authority is hereby conveyed to release of Rs.20,00,000/- (Rupees twenty lakh only) (including applicable taxes) as lump sum grant, through e-payment (Bank details enclosed) in favour of "The Director General & Pr. Secy (Training) HCM, Rajasthan State Institute of Public Administration, Jaipur, Rajasthan", for continuation of Sevottam Training Cell in the Academy, established under sub-scheme under Sevottam (Plan) titled "Scheme for Strengthening of State Administrative Training Institutes/Central Training Institutes" during the 12th Plan Period. HCM, Rajasthan State Institute of Public Administration, Jaipur, Rajasthan shall submit achievement-cum-performance report within one month after the closure of financial year. A certificate of actual utilization of the grant, including the unspent balance carried forward prescribed for each component, should also be furnished as per the GFR 12 – C (Rule 239 of GFR 2017). However, expenditure on hardware for Sevottam Cell may be incurred after furnishing an undertaking that no funds for the purpose are being received under any other scheme.

2. The expenditure involved is debatable to Major Head 2070- Other Administrative Services 42.01.20, Other Administrative Expenses, Component – Sevottam, under Demand No.74, Ministry of Personnel, Public Grievances and Pensions for the CFY 2022-23.

3. The Sanction is based on the concurrence of IFD vide note # 92, Dated 08.06.2022.


