



1. Key Highlights

- 1. General
- Meeting with Grievance Redressal Officers of the States/UTs was held on 26th April, 2023, to review the pendency and disposal of public grievances on CPGRAMS and progress of integration of State/UT portals with CPGRAMS. Nodal Officers were requested to have regular meetings with GROs to expedite redressal and improve average closing time
- Dedicated meeting with Grievance Redressal Officers of North Eastern States was also held on 26th April, 2023. Comments from North Eastern states were sought on the subject "Effective Redressal of Grievances by Strengthening Public Grievance System"
- Beta version of Sevottam Training Programmes Monitoring Portal is ready and a demonstration was given to ATIs in the review meetings held on 26th April 2023
- 2. PG Cases
- In April, 2023, **57,630 PG cases** were received for the States/UTs and **55,742 PG cases** were redressed
- For States/UTs, as on 30th April 2023, there exists a pendency of 2,03,409 PG cases
- The pendency in the States/UTs has increased from 2,01,523 PG cases at the end of March, 2023 to 2,03,409 PG cases at the end of April, 2023
- For the 8th month in a row, the monthly disposal crossed 50 thousand cases in States/UTs
- **Government of Uttar Pradesh** has received the maximum number of grievances in April, 2023 with the number standing at 18,322 grievances and disposed the maximum number of grievances with the number standing at 20,074 grievances
- 3. Pendency
- 22 States/UTs have more than 1000 pending grievances as on 30th April, 2023
- Government of Maharashtra has the maximum number of pending grievances (overall and pending for more than 30 days) with the number standing at 23,758 grievances (overall) and 20,168 grievances (pending for more than 30 days)
- 4. PG Officers
- 34,506 PG Officers from States/UTs are mapped onto the CPGRAMS Portal
- Government of Haryana has the highest number of PG officers mapped onto CPGRAMS with 7,477 PG Officers mapped
- 5. Average Closing Time
- 25 States/UTs have their Average Closing Time of grievances more than the Standard Redressal Time of 30 days




2.2. Month-wise Status of Grievances




3. Age-wise Status of Grievances

3.1. Pendency




- **79.13** % of total pendency i.e., 160952 grievances have been pending disposal for more than 30 Days
- 37.67 % of total pendency has been ageing for more than 6 months i.e., 76,618 grievances. Such huge time delays in disposing grievances shall considerably affect Average Closing Time of respective States/UTs
- Government of West Bengal, Government of Maharashtra and Government of Bihar are the only 3 States with each having more than 3000 grievances pending disposal for more than 1 year. The numbers stand at 3957, 3686 and 3260 grievances respectively

3.2. Disposal




- Major chunk of grievances i.e., 60.47 % of total disposals have happened within the Standard Grievance Redressal Time of 30 Days
- Government of Telangana and Government of Union Territory of Lakshadweep are the only 2 states which have disposed of all their grievances within 6 months' time period whereas Government of Mizoram's 61.49 % disposals were after the grievances had aged for more than 6 months
- Total 7 States/UTs have disposed of all their grievances within 1 year time period. 5 States/UTs, apart from the above 2, are namely Government of Union Territory of Dadra & Nagar Haveli and Daman & Diu, Government of Sikkim, Government of Arunachal Pradesh, Government of Andaman & Nicobar and Government of Jammu and Kashmir




4. BSNL Feedback Call Centre


From 1st April, 2023 to 30th April, 2023, the BSNL Feedback Call Centre has collected
 27139 feedbacks, directly from the citizens




• A total of **8682 citizens** have given the Satisfaction level for their Grievance Redressal as "Satisfied"

5. Parliamentary Standing Committee

The Department appeared before the Parliamentary Standing Committee of Ministry of Personnel, Public Grievances and Pensions on 28th April, 2023. The Department has implemented 36 recommendations of PSC in the period 2019-23

Parliamentary Standing Committee Recommendations under implementation by Department:

- <u>Separate Grievance Portals for NE States</u> Consultation meeting held with North Eastern States on 26th April, 2023
- <u>Focus on Disposal Quality</u> The BSNL Call Centre has been requested to improve the % of successful calls made for seeking feedback on disposed grievances to achieve the target of maximum disposal quality of grievances. Technology upgradation of BSNL, live dashboard for BSNL data analytics and SMS in Regional languages are also under process.
- <u>Scheme-wise analysis by Data Strategy Unit</u> PMAY Scheme examined in March.
 3 Schemes namely Samagra Siksha, Health & Wellness Centres, Har Ghar Jal to be examined in April, 2023
- <u>Voice enabled Grievance lodging</u> BSNL has been directed to explore the setting up of an incoming call centre so that voice enabled grievances can be lodged
- <u>Disposal rate of State/UT related grievances</u> Dedicated monthly review meetings being held. Conference with States/UTs to be held in YASHADA, Pune on 23rd May, 2023
- <u>Improvements in My Grievance App</u> The NIC has been requested to ensure that the application "MyGrievance App" to be upgraded for iOS and Android version. Department partnering with IIT Kanpur
- <u>Grievance Redressal Index</u> Monthly Reviews of GRAI Data Sets with Central Ministries/Departments being undertaken

6. Outreach through Common Service Centres (CSCs)

 CPGRAMS has been integrated with the Common Service Centre (CSC) portal and is available at more than 5 lakh CSCs, associating with 2.5 lakh Village Level Entrepreneurs (VLEs). This integration has also helped the citizens in availing CPGRAMS related services in remote corners of the country owing to its presence in all the Gram Panchayats



- A total of **29,975 grievances** have been registered through the Common Service Centres in the year 2023 till 30th April, 2023
- The Government of Punjab has received the maximum number of grievances with the department receiving 8999 grievances in 2023, followed by the Government of Uttar Pradesh at the 2nd place, with the number standing at 6655 registrations

- 91.75 % of grievances received by Government of Manipur in the year 2023 have been filed through CSCs i.e., 2236 grievances out of 2437 receipts have been registered through CSCs
- 7 States/UTs namely Government of Manipur, Government of West Bengal, Government of Jammu and Kashmir, Government of Nagaland, Government of Mizoram, Government of Tripura and Government of Union Territory of Daman & Diu have not disposed of a single grievance received through CSCs.
- The category "*PMKISAN related issues*" has received the maximum number of grievances with the number standing at 27013 grievances i.e.,90.12 % of total registrations through CSCs were PM KISAN related issues

- With respect to States/UTs, maximum grievances originated out of Punjab (8914 registrations) followed by Uttar Pradesh at 2nd place with 6628 grievances registered through CSCs
- With respect to Districts, maximum grievances originated out of Tamenglong (MN) (2236 registrations) followed by Muktsar (PB) at 2nd place with 1474 grievances registered through CSCs

7. Performance of States/UTs

- For States/UTs, till 30th April, 2023, a total of 252467 grievances have been received with additional 187051 grievances being brought forward from the year 2022, 236109 grievances have been disposed of while 203409 grievances are still pending disposal
- For the month of April, 2023, the Government of Uttar Pradesh has received the maximum number of grievances with the state receiving 18322 grievances, followed by the Government of Punjab at 2nd place, with the number standing at 5331 registrations. The Government of Maharashtra with 3934 receipts in April, completes the Top 3 positions
- Government of Assam recorded 2228 grievances in the month of April, thus placing it 9th in the list, with the Top 10 being closed by the Government of Bihar which has received 1897 grievances
- In the month of April, 2023, the Government of Uttar Pradesh has disposed of the maximum number of grievances (20074) followed by the Government of Bihar disposing of 8011 grievances
- Government of Maharashtra with a pendency of 23758 grievances tops the list of States/UTs with the highest pendency, the Government of West Bengal with a pendency of 17862 grievances stands at the 3rd position, and the Government of Odisha with a pendency of 12855 grievances stands at the 7th position
- As of 30th April, 2023, Government of Maharashtra is the only state with a pendency of more than 20,000 grievances while 7 states have more than 10,000 pending grievances

8. Average Closing Time of Grievances

- Overall Average Closing Time of all States/UTs is 50 Days
- Overall Average Closing Time of North-Eastern States is 60 Days
- Government of Mizoram has the highest Average Closing Time of 247 days (against 335 disposals), followed by the Government of Punjab standing at the 2nd position with an Average Closing Time of 135 days (against 14320 disposals). The Government of Bihar with an Average Closing Time of 133 days (against 28775 disposals) closes out the Top 3 positions, whereas Government of Union Territory of Ladakh averaging 119 days (against 433 disposals) stands at the 4th position. Government of Andhra Pradesh taking an average of 97 days to close out a grievance (against 1247 disposals) stood at the 6th position, the Government of Tripura recording an average of 75 days (against 2139 disposals) closed out the Top 10 list

- Government of Telangana with Average Closing time of 6 days (against 8270 disposals) tops the list of States/UTs with lowest Average Closing Time, followed by the Government of Union Territory of Lakshadweep at the 2nd position which averaged 15 days (against 548 disposal) and the Government of Jammu & Kashmir at the 3rd position, registering an Average Closing Time of 22 days (against 2473 disposal)
- Government of Goa stands at the 4th place with an Average Closing Time of 23 days (against 1786 disposals), the Government of Chattisgarh standing at the 6th place, with an Average Closing Time of 25 days (against 10131 disposals), and the Government of Arunachal Pradesh averaging 27 days (against 678 disposals) stands at the 9th place. Government of Union Territory of Chandigarh with an Average Closing Time of 29 days (against 4216 disposals) closes out the Top 10 list.

9. Public Grievance Officers

- Number of PG officers mapped onto CPGRAMS for States/UTs stands at 34,506 officers
- Government of Haryana has the maximum number of mappings with the figure standing at 7477 officers, followed by the Government of Maharashtra which has mapped 5117 officers, and the Government of Gujarat standing at the 3rd place with 4787 mappings
- The Top 10 list is closed by the Government of Tamil Nadu and the Government of Bihar with the former securing 9th place with 1377 mappings, and the latter standing at the 10th position with 1070 officers mapped onto the CPGRAMS

10. Integration of State/UT Portals with CPGRAMS

- Under the One Nation-One Portal vision, the Department of Administrative Reforms and Public Grievances has undertaken a massive mandate of linking all the respective State/UT portals with CPGRAMS
- 18 States/UTs which have dedicated public grievance portals, 2 States namely Tamil Nadu and West Bengal are pending with Forward Integration with CPGRAMS, which means the grievances received on CPGRAMS pertaining to the 2 States cannot be pushed to/consumed by the State portals
- 4 States with dedicated public grievance portals, namely Bihar, Kerala, Tamil Nadu and West Bengal are pending with Reverse Integration with CPGRAMS, which means that the grievances received by these State portals cannot be pushed to/consumed by CPGRAMS

• Kerala and West Bengal are the 2 States which still do not feature the CPGRAMS link on their state portal to enable the re-direction of the citizen

11. Sevottam Scheme

- In a major capacity building effort, the Department of Administrative Reforms & Public Grievances has launched a major scheme "Sevottam", under which the Department Funds State ATIs/CTIs, for setting up of a Sevottam Training cell in the ATI for capacity building of grievance redressal officers
- DARPG vide D.O. letter dated 15.06.2022 and 02.12.2022 from the Secretary (AR&PG) has requested allthe remaining States/UTs for sending their proposal for Sevottam
- Under the scheme, there is a provision for a lump-sum grant of up to Rs. 20 lakhs per year to each of the State ATIs/CTIs, and the Department has requested the States/UTs for self-contained proposals regarding the same
- Grants to 19 States/UTs namely Haryana, Punjab, Uttar Pradesh, Jharkhand, Madhya Pradesh, Rajasthan, Meghalaya, West Bengal, Maharashtra, Gujarat, Andhra Pradesh, Telangana, Tamil Nadu, Himachal Pradesh, Goa, Tripura, Mizoram, Kerala and Jammu & Kashmir have been released
- The proposals of 3 States namely Karnataka, Odisha and Sikkim are under process, for FY 22-23
- New proposals of 3 states namely Assam, Haryana and Delhi have been received for FY 23-24
- States are requested to submit their respective Sevottam proposals within 3 months of FY 23-24
