

This is a proposal of DoPT seeking concurrence of IFD for release of 2nd installment of Rs. 50.00 lakh w.r.t. SCI Project Chambayal 2.0 under State Collaboration Initiative Scheme, District Chamba, Himachal Pradesh,

2. SMD has stated that the Project Chambayal 2.0 was concurred by IFD and subsequently vide sanction dated 05.12.2024 an amount of Rs. 50.00 lakh was released as 1st installment. Now, the implementing agency vide letter dated 01.03.2025 has furnished UC for the 1st installment alongwith expenditure statement and progress report and have requested for release of next installment.

3. SMD has stated that in the progress report a brief overview has been shared stating that a workshop was conducted on 05.02.2025 on art and craft of district Chamba under the chairmanship of DC Chamba along with the total participants of 110 people and with the resource persons from Central University Kangra, NIFT Kangra and a Famous artisan from Kullu. Also, An Art and craft Center Rang Mahal is to be renovated and reorganized for Conducting training workshops and exhibition of Galleries. In this regard, funds have released to HPPWD , Chamba.

4. The proposal of DARPG has been examined and it has been observed the proposed expenditure shall be booked under GIA General under SCI for the year 2024-25 wherein Rs. 424 lakh is available.

Accordingly, IFD may concur with the proposal of DARPG for release of 2nd installment of Rs. 50.00 lakh w.r.t. SCI Project Chambayal 2.0 under State Collaboration Initiative Scheme, District Chamba, Himachal Pradesh subject to the availability of funds and approval of the competent authority.
