This is a proposal of DARPG seeking concurrence of IFD for release of 2nd installment of Rs. 50,00,000/- w.r.t. the SCI Project Catalyzing Public Service Excellence in Meghalaya.

2. It is pertinent to mention here that 06 projects of DARPG with a total cost of Rs. 2,22,39,738/- was concurred by IFD. SMD has stated that the proposal for release of 2nd installment of Rs. 50.00 lakh w.r.t. SCI Project Catalyzing Public Service Excellence in Meghalaya was examined by the department and AS(AR) asked to mention the key components of the approved project. Subsequently the implementing agency vide their email dated 12.03.2025 furnished the key project components and resource allocation of the SCI Project mentioning therein that a new component has been added with the reasons that this aligns with the objectives of public service excellence, digital transformation and citizen empowerment and is proposed within the sanctioned amount of the project.

3. The implementing agency has further stated that the inclusion of this component is based on anticipated savings from the transition of offline services to online platforms. Additionally, citizen feedback was received highlighting the need for a mobile app to enhance accessibility and ease of use. A mobile app will provide a more user-friendly, seamless, and efficient platform for accessing services, particularly benefiting users who rely primarily on smartphones. It will further improve service delivery.

4. In view of the above, IFD may concur with the proposal of DARPG for release of 2nd installment of Rs. 50,00,000/- w.r.t. the SCI Project Catalyzing Public Service Excellence in Meghalaya subject to the availability of funds under GIA General and approval of the competent authority.
