This is a proposal of DARPG seeking concurrence of IFD for release of 4th installment of Rs. 40.00 lakh for implementation of the Project "District Smart Control Room (DSCR)" of District Disaster Management Authority, Uttarkashi under the State Collaboration Initiative (SCI) Scheme.

- 2. SMD has furnished the UC for Rs. 50 lakh received from the District Administration, Uttarkashi, Govt. of Uttarakhand vide letter dated 24.01.2025 and have stated that entire amount has been utilized. District Administration, Uttarkashi has also forwarded expenditure statement alongwith progress report of the project.
- 3. The proposal was examined by AS (AR) vide note#93 and specific observations were raised. Accordingly, SMD sent an email dated 03.03.2025 to the implementing agency and in response the agency has stated that the total amount received was Rs. 1.60 cr, out of which Rs. 1.52 cr has been paid to the stakeholder through invoice. The remaining balance alongwith the payment for hiring of dedicated staff for the maintenance of the smart control room will be covered through final installment of Rs. 40 lakh. Secondly, the expansion of the project including the transition from IP to optical fibre as well as crowd, traffic and tracker management system is considered as part of a separate project and will be considered in the next FY.
- 3. The proposal of DARPG has been examined and it has been observed that the proposed expenditure for 4th installment will be met from GIA General under SCI Initiative.

Accordingly, we may concur with the proposal of DARPG for release of 3rd installment of Rs. 40.00 lakh for implementation of the Project "District Smart Control Room (DSCR)" of District Disaster Management Authority, Uttarkashi under the State Collaboration Initiative (SCI) Scheme subject to the availability of funds and approval of the competent authority.
