## Achievements During the month of April, 2022

# (i) <u>Regional Conference on "Bringing Citizens and Government Closer</u> through Administrative Reforms"

A 2-day Regional Conference on the theme "Bringing Citizens and Government Closer through Administrative Reforms" was organized at Itanagar on August 18-19, 2022 in collaboration with Government of Arunachal Pradesh. Dr. Jitendra Singh, Hon'ble MOS (PP) inaugurated the Conference in presence of Shri Pema Khandu, Hon'ble Chief Minister of Arunachal Pradesh and Shri Chowna Mein, Hon'ble Deputy Chief Minister of Arunachal Pradesh. Senior Cabinet Ministers in Arunachal Pradesh Government were present on the occasion. About 300 delegates from NE States and from the Odisha, Jharkhand Bihar attended this conference. DARPG agreed to provide support to the Government of Arunachal Pradesh for implementation of latest version of e-office in the State and mid-career training programmes for 500 officers of the Arunachal Pradesh Administrative Services through NCGG.

## (ii) 5th National Good Governance Webinar

DARPG, in coordination with National Centre for Good Governance, conducted webinar on the theme 'Environment'. This was the 5th Webinar in the series of sharing best initiatives awarded under the Prime Ministers award for excellence in Public Administration. Canal Top Solar Power Plant of Gujarat State Electricity Corporation and "Revival of Sasur Khaderi-2, project of Fatehpur, UP" were presented in the webinar.

### (iii) National Awards for e-Governance

DARPG received a total of 432 nominations for National Awards for e-Governance 2021-22. Last date for filing application for the award was 20.08.2022. Meetings of Screening Committee have commenced w.e.f. 31.08.2022 for shortlisting the nominations at stage 1.

## (iv) Centralised Public Grievance Redress & Monitoring System (CPGRAMS)

CPGRAMS portal has been operationalized in all scheduled languages. DARPG held meeting with all nodal officers and appellate authorities on 05.08.2022 to inform them about the new guidelines / Master Circular issued by DARPG regarding disposal of public grievances.
