


to provide for the delivery of public service to eligible person within the Notified time limits.



Notable futures of the Act

- At present 370 Services have been notified under Act relating to 27 Government Department/undertakings.
- Designated Officers notified under Section 3 of the Act: provide service or reject the application within the notified time limit and in case of rejection, record reasons in writing and intimate to the applicant.
- Every Designated Officer to maintain a record regarding services applied for in a register as per Form-A.
- Notified time limit starts from the date with requisite complete application for notified service received.


✤Provisions of two appeals against the rejection by Designated Officer.

Ist Appeal to be filed within 30 days and to be decided by First Appellate Authority within 30 days.

✤2nd Appeal can be filed within 60 days from the rejection of first appeal and to be decided within 30 days.


Aggrieved person can file a revision before the Commission within 90 days of the 2nd appeal orders.

The Commission has Suo Moto powers to entertain petitions under the Act.



Constitution of HRTS Commission

- Chief Commissioner and Four Commissioners.
- Term-five years or 65 of the age which ever earlier.
- Status of Chief Commissioner equivalent to State Chief Information Commissioner...recently downgraded to Chief Secretary.
- Commissioner equivalent to Information Commissioner...recently down graded to Principal Secretary/Additional Secretary.



Punitive Powers

- Second Appellate Authority can impose a lump sum penalty on Designated Officer which are not less then Rs. 250/- and more then Rs. 5000/-.
- The Commission has power to impose a penalty on Designated ?Officer or any other official involved in the process providing notified services up to a sum of Rs. 20,000/- and may also allow compensation up to Rs. 5000/-to be paid to eligible person by defaulter.
- Commission also may recommend Departmental action against any officer or employee of the State Government.
- Commission can recommend changes in procedure and process of re-engineering for delivery of services.

Impact of the Act.

- Every Designated Officer-cum-First Appellate Authority and Second Appellate Authority have displayed the notified services in a Notice Board outside their offices.
- Every Designated Officer is maintaining a record as per Form 'A' containing of receipt of application, date of disposal and reasons for refusal.
- The Commission has conducted 1600 inspections to ensure display of Notice Board & maintenance of record in the prescribed format.





- One can send Application/Complaint online on website besides email and post.


Inspection of implementing office from time to time.

Way Forward:

- State Government purposes provision of automatic appeal on the expiry of time limit in case of Designated Officer and two Appellate Authorities. Amendment in the Act being worked out.
- An undertaking will be obtained from the applicant at the time of filing the application.
- Commission has recommended to the State Government to make provision for one appeal in case of the two appeals to cut down the time for conclusion of delivery of service.
