This is a proposal of DARPG seeking concurrence of IFD for release of fourth and last installment of Rs. 21.46 lakh w.r.t. the SCI Project 'Preparation and Dissemination of Comprehensive Job Charts for Personnel at Cutting edge level by Institute of Management in Govt., Thiruvananthapuram, Kerala".

2. It is pertinent to mention here that the proposal of DARPG was last examined by IFD vide [note#94](#) and it was observed that it may be more appropriate if the actual expenditure incurred on the approved project is obtained from the implementing agency before further release as the UC provided by the implementing agency mentions that the fund has been utilized for which it was sanctioned.

3. The proposal has been re-submitted and in reply to the observation raised by IFD, SMD has stated vide [para 5-6](#), [note#106](#) that explanation was sought from the implementing agency vide letter dated [26.09.2024](#) and in response vide email dated [26.09.2024](#) the implementing agency has stated that the initial number of cadres in the original proposal submitted were only 52 and once the project was approved and after departmental task forces were constituted, IMG and team did a thorough analysis of the entire gamut of work done by the respective departments. The IMG and the Departments took a studied view that the entire frontline staff of the Departments involved viz., Industrial Training, Social Justice and Women and Child Development totaling 112 Cadres should be included. This was explicitly mentioned in the 1st quarterly status Report sent along with UC of the 1st installment.

4. It is further mentioned that the departments agreed to optimize the available resources and committed resources without requesting additional resources from DARPG. Accordingly, IMG and departments partnered professionally to develop the Comprehensive Job Charts for 112 cutting edge personnel, which since has been validated and endorsed by the departments. The proposal has been submitted with the approval of AS(AR) vide [note#108](#).

5. In view of the above, IFD may agree with the proposal of DARPG for release of fourth and last installment of Rs. 21.46 lakh w.r.t. the SCI Project 'Preparation and Dissemination of Comprehensive Job Charts for Personnel at Cutting edge level by Institute of Management in Govt., Thiruvananthapuram, Kerala" subject to the availability of funds from GIA General under SCI initiative and approval of the competent authority.
