Important achievements /activities during the month of January 2022 are as under:

(i) Prime Minister's Awards for Excellence in Public Administration 2022

The Screening Committee constituted for evaluation of applications for Prime Minister's Awards for Excellence in Public Administration 2022 evaluated the applications on the following identified categories for Awards:

- a. Promoting Swachh Jal (Clean Jal) through Har Ghar Jal Yojana
- b. Promoting Swasth Bharat (Healthy Bharat) through Health & Wellness Centres
- c. Promoting quality education with an equitable and inclusive classroom environment through Samagra Shiksha.
- d. Holistic Development through Aspirational District Program overall progress with special focus on saturation approach.
- e. Innovations.
- 2. The Screening Committee First and Second Stage Meetings for evaluation and shortlisting of nominations have been held in the period 9th December, 2022 to 4th January, 2023 and 30th January, 2023 to 3rd February, 2023 respectively.

(ii) Regional Conference on the theme "e-Governance"

The Department in collaboration with Government of Maharashtra organized a 2 day Regional Conference on the theme "e-Governance" at Mumbai on January 23 – 24th, 2023. One documentary film of around 7-8 minutes in Hindi language on the year-end review of DARPG was also produced and screened during the Conference.

Hon'ble MoS(PP) released a Coffee Table Book on the achievements of Good Governance Week 2022- Nation-wide Campaign 'Prashasan Gaon Ki Ore 2022' on 24th January, 2023, during the two day Regional Conference on 'e-Governance' held in Mumbai on 23rd-24th January, 2023

(iii) National eGovernance Service Delivery Assessment (NeSDA), 2021

The 2nd meeting to formulate a Roadmap for timely implementation of National eServices Delivery Assessment (NeSDA)'s, 2021 recommendations in all States & UTs was convened on January 09, 2023 under the chairmanship of Secretary, DARPG with principal Secretaries (AR)/Secretaries (AR) of all the States/UTs.

8th meeting of Working Committee for, Vision India@2047' under the Chairmanship of Secretary, DARPG was held on 9th January, 2023.

(iv) Centralised Public Grievance Redress & Monitoring System (CPGRAMS)

Hon'ble MOS (PP) addressed the council of ministries on 4th January, 2023, enclosing a copy of Annual Report of CPGRAMS 2022.

A meeting through VC under the Chairmanship of Secretary, DARPG was held on 04.01.2023 with the Nodal Public Grievance Officers of Central Ministries / Departments to review the disposal/pendency position of public grievances received in CPGRAMS in all Ministries/Departments and way forward.

CPGRAMS Monthly Report for the month of December, 2022 in respect of Central Ministries / Departments has been brought out. The same was circulated to all Secretaries to the Government of India.

A meeting through VC under the Chairmanship of Secretary, DARPG was held on 04.01.2023 with the Nodal Public Grievance Officers of States/UTs to review the disposal/pendency position of public grievances received in CPGRAMS and progress of integration State/UT portals with CPGRAMS.

CPGRAMS Monthly Report for the month of December, 2022 in respect of States and UTs has been brought out and circulated to Chief Secretaries of States.

(v) National Good Governance Webinar Series

The 10th Webinar under the National Good Governance Webinar Series was successfully organized on 27th January 2023. The theme of the 10th Webinar was 'Innovations at District Level'. The awardees for the innovative initiatives (i) Bleed with Pride', District Imphal East, Manipur (2020) and (ii) 'e-Attendance Application (Lok Sewak)' by e-Governance Society, District Khandwa, Madhya Pradesh (2019) were invited as Lead- speakers. The webinar witnessed active participation of more than 1000 participants

(vi) Implementation of eOffice - Migration to eOffice version 7.0

As on date 72 Ministries/Departments out of 77 have been migrated to e-office version 7.0. As per the directions given by Cabinet Secretary during the workshop on GGW on 23.12.2022 the remaining 5 (Five) Ministries are likely to be migrated by February, 2023. Besides these 15 Apex Bodies, 195 attached offices and 60 PSUs have been migrated to the new version.

(vii) Special Campaign on disposal of pendency
