A review meeting of SCI projects was held on 18.07.2023 through video conference under the Chairmanship of Shri NBS Rajput, Joint Secretary, D/o AR&PG.

2. At the outset Sh. NBS Rajput, Joint Secretary, DARPG welcomed the participants for attending the meeting despite their hectic schedule. The Status of 10 projects where first instalment has been released but physical and financial progress has not been reported by the implementing agencies was discussed. The implementing Agencies/Nodal Officers of the project were requested to present the progress of the implementation of the project.
