Achievements During the month of October, 2023

(i) Special Campaign 3.0 for Swachhata and Disposal of Pending Matters

During the month, Special campaign 3.0 for Swachhata and disposal of pending matters was conducted from 2nd October - 31st October, 2023. All Ministries / Departments participated in the Special campaign in a befitting manner.

Hon'ble MoS (PP) addressed two press conferences in National Media Centre, first on 14th September, 2023 on launch of portal and the preparatory phase and second on 25th October, 2023 on Mid-campaign progress. 6 panel discussions on DD News / Sansad TV and AIR were held on the Special campaign 3.0. The Special Campaign 3.0 was presented by Ministries / Departments in social media with over 75,000 social media posts (tweets/ Instagram/ facebook etc.) including 800 tweets from DARPG handle, 1100 infographics on #Special Campaign 3.0 hash tag and issue of 258 PIB statements.

Special Campaign 3.0 has concluded on 31st October, 2023 with outstanding results and after collating all the data, the external evaluation by QCI team will be done from November 15-30, 2023.

The campaign witnessed widespread participation across Ministries/Departments and their field/outstation offices and significant outcomes have been achieved. The following are the key outcomes of the campaign as per preliminary data reported by Ministries on the portal:

(ii) <u>Centralized Public Grievance Redress & Monitoring System (CPGRAMS)</u>

Performance of all stakeholders on CPGRAMS- Central Ministries/ Departments, States/ UTs and Knowledge Partners were reviewed by Secretary, DARPG on 12th October, 2023. Disposal of grievances both in terms of average time taken and quality of disposal have seen improvement due to regular reviews undertaken by DARPG with States/ UTs and Central Ministries.

CPGRAMS monthly Reports for the month of September 2023 in respect of Central Ministries and States/ UTs were released and circulated to all Secretaries to the Govt. of India and Chief Secretaries of States/ UTs respectively.

(iii) National Good Governance Webinar

The 18th Webinar under the National Good Governance Webinar Series was organised with the Theme "Promoting Swasth Bharat- Ayushmaan Bharat through Health & Wellness Centres'. Shri Prithviraj B.P., CEO, Nagur Smart and Sustainable City Development Corporation Ltd., the then District Collector, Latur, Maharashtra and Shri Ravi Pattanshetti, District Collector, Ankapalli, Andhra presented the initiatives taken by them in the respective districts.

(iv) <u>National e-Governance Services Delivery Assessment (NeSDA) – 2023</u>

Review meetings with all Single Point of Contacts (SPOCs) were held on 12th October, 18th October and 30th October, 2023 to monitor the status and also to start the Stage-4, i.e. analysis of the answers to the questionnaire which have already been submitted.

(v) National e-Governance Webinar Series (NeGW-2023-24)

DARPG convened the second webinar under the national e-Governance Webinar series with the theme "Excellence in Government Process Re-engineering for Digital Transformation at Central Level" on October 20, 2023. The awarded initiatives of (i) e-Panchayat Mission Mode Project (eGramSwaraj & Audit Online) and (ii) PM Street Vendors Atma Nirbhar Nidhi (PM SVANidhi), were presented by Shri Rahul Kapoor, Joint Secretary, Ministry of Housing & Urban Affairs and by Shri. Alok Prem Nagar, Joint Secretary, Ministry of Panchayati Raj respectively.

(vi) National Awards for e-Governance 2024 Scheme

The Award Scheme for National Awards for e-Governance 2024 (NAeG 2024) has been approved by Hon'ble MoS (PP).

(vii) International Exchange and Cooperation

A two member delegation headed by Shri Puneet Yadav, JS along with Shri S.K. Pandey, Director (IE&C) visited Brussels from October 3-5, 2023 and attended the Extraordinary General Body meeting of IIAS for vote on the amendments in statutes of IIAS. Change in venue of IIAS Conference 2025 from Kochi to New Delhi was also discussed along with other issues.

(viii) **Documentation and Dissemination activities**

The Department of Administrative Reforms & Public Grievances successfully convened a two-day Regional Conference in collaboration with Government of Rajasthan on Good Governance at Jaipur on 4th -5th October, 2023. Regional Conference in collaboration with Government of Rajasthan was organized by the Department after 7 years. The main objective of the Conference was to generate awareness amongst the participants about the recent reforms for promotion of good governance. It also brought national and state level public administration organizations on the same platform to share experiences about innovations in public administration, transforming future public solution for improving quality of life, good governance, e-Governance, Digital Governance, etc. Dr. Jitendra Singh, Hon'ble MoS (PP) addressed the Conference on 4th October, 2023. The Conference featured 13 Award Winners in 7 categories from 2022 Awardees; the PM's Award winners/National e-Governance Award Winners from Rajasthan and also presented the best governance practices in Rajasthan. All States/UTs were participated in the two-day event through physical as well as VC mode. The event was extensively covered by National, local media and also on social media.
