(a) International Institute of Administrative Sciences (IIAS) - DARPG India Conference 2025

The IIAS-DARPG India Conference 2025 was successfully held from 10th to 14th February 2025 in Bharat Mandapam, New Delhi. This event fostered knowledge dissemination across India's apex Public Policy Institutions and Universities. The five-day event witnessed the participation of over 750 delegates from 58 countries, including policymakers, academics and practitioners, who engaged in discussions on transformative governance models and inclusive public administration. Young achievers from State Governments, Central Government, apex Public Policy Institutions and Universities had the opportunity to present their work in this global forum and thousands of officials participated in the Conference deliberations online as the alumni of the National Centre for Good Governance from 34 countries.

One of the largest ever Conference conducted by IIAS in its 100-year history, it witnessed revitalized multi-lateralism with experts from United States, Europe and Asia exchanging knowledge, the amplified voice of the global South with many presentations from developing countries, the efforts being made to adopt Next Generation Reforms and empowering citizens at the last mile.

A 710-page volume edited by distinguished authors and experts titled "Viksit Bharat@2047: Governance Transformed" was launched. The book delves into

India's governance evolution and outlines a strategic road map to achieve developed nation status by 2047.

During the IIAS-DARPG India Conference 2025, India fervently presented its case for the post of President amongst three other Presidential candidates from Austria, Bahrain and South Africa.

(b) National Awards for e-Governance

As of February 28, 2025, nominations for the National Awards for e-Governance have been invited, with 589 final applications received across six award categories.

(c) 'NeSDA Way Forward' monthly Report

The January 2025 edition of the "NeSDA Way Forward" monthly report for States and Union Territories has been released, highlighting a total of 19,834 recorded eservices. Out of the 2,016 mandatory eservices (56 per each of the 36 States/UTs), 1,584 are currently available, achieving a saturation level of over 78%.

(d) Launch of Prime Minister's Awards, 2024 portal

Total 1588 online nominations were received on the PM Awards web-portal (pmawards.gov.in) under Prime Minister's Awards for Excellence in Public Administration, 2024 within the prescribed timeline of 21st February, 2025, in the following categories:

Category 1: Holistic Development of Districts

Category 2: Aspirational Blocks Programme

Category 3: Innovations for Central Ministries/Departments, States, Districts

The category-wise nominations received were as under:

- (a) Holistic Development of Districts 437
- (b) Aspirational Blocks Programme -426
- (c) Innovations 725

(e) Redressal of Public Grievances - Meeting with Right to Service Chief Commissioners

In pursuance of the Hon'ble Prime Minister's directions in PRAGATI review meeting dated 26.12.2024, the Department has deepened the CPGRAMS-10 Step Reforms with focus on quality of grievance redressal and improving citizen satisfaction. These reforms include introduction of Senior Officer Level Reviews of Grievance Redressal, Capacity Building Programs for GRO's under SEVOTTAM, Technology up gradation under the Next-gen CPGRAMS project and Effective

Metrics for monitoring quality of grievance redressal, adopting best practices from States, collaboration with Right To Services Commissions and improvements in the Feedback collection practices with the Feedback Call Centre, Documentation and Dissemination of success stories, enhanced media outreach on the CPGRAMS benefits.

The adoption of this 10-Step process has resulted in timely and qualitative disposal of public grievances in the period 2019-2024, during which period 1.12 crore public grievances have been redressed on the CPGRAMS portal, 103675 Grievance Redressal Officers have been mapped and over 30 lac citizens registered on the portal. The grievance redressal timelines have been brought down to 15 days, and over 20 lac citizen feedbacks have been collected through the feedback call center. It is envisaged that the deepening of the CPGRAMS 10-Step Reforms will ensure greater efficiency, accountability, and citizen satisfaction in grievance redressal.
