4. The above release is subject to the following conditions: -


- (i) The host department shall submit quarterly monitoring report to DARPG.





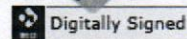

This is a proposal of DARPG seeking concurrence of IFD for release of 3rd installment of Rs. 48.82 lakh (25% of 195.28 lakh) for implementation of the Project Smart Classes and Digital Library for 27

selected school, Niwari District, MP.

2. SMD has mentioned that the instant project was recommended by the Screening Committee in its meeting held on 21.12.2022 and the proposal was concurred by IFD (p-17-19/c). Accordingly, first installment of Rs. 48.82 lakh was released vide sanction order dated 23.02.2023 followed by subsequent release of 2nd installment of Rs. 48.82 lakh vide sanction dated 22.03.2024 .

3. Now, the Implementing Agency vide letter dated 2.06.2024 has furnished the project completion report and has stated that the apparatus of the project implementation has been provided in 27 schools. Earlier the implementing agency had also furnished UC and progress report.

4. The implementing agency vide its communication dated 24.05.2024 has stated that the total cost of implementation of the said project comes out to be Rs. 1,81,99,350/- out of which Rs. 97.64 lakh has already been paid and have sought release of Rs. 84,35,350/- as committed liability to the Vendor Perfect World Computers, Bhopal. The agency has also furnished the completion report and photographs alongwith the list of schools wherein the project was implemented. The proposal has been submitted with the approval of AS(AR) for release of Rs. 48.82 lakh i.e. 25% of Rs. 195.28 lakh as 3rd installment.

5. The proposal of DARPG has been examined and it has been observed that the proposed expenditure will be booked from Scheme for Administrative Reforms under GIA head of State Collaborative Initiative for the year 2024-25.

Accordingly, we may concur with the proposal of DARPG for release of 3rd installment of Rs. 48.82 lakh (25% of 195.28 lakh) for implementation of the Project Smart Classes and Digital Library for 27 selected school, Niwari District, MP subject to the availability of funds and approval of the competent authority.
