**Monthly summary for the month of November, 2021**

Important achievements /activities during the month of November, 2021 are as under:

**International Exchange & Cooperation**

(i) The First meeting of India - Gambia Joint Working Group (JWG) was held virtually on 22<sup>nd</sup> November, 2021 under the aegis of the MoU signed between Department of Administrative Reforms & Public Grievances (DARPG) and the Public Service Commission (PSC), Government of the Republic of Gambia. During the meeting 6 presentations were made by experts from the Indian side on e-HRMS, Mission Karamyogi, e-Office, e-Recruitment, e-examination and pension reforms including New Pension Scheme.

**Special Campaign for Disposal of Pending Matters**

(iii) Preliminary reports on Special Campaign containing (a) Third Party Evaluation of Swachhta assessment (b) Desktop Assessment of Matrix on Dashboard and (c) Self-Assessment of Ministries were submitted to the Cabinet Secretariat. It has been decided that the monitoring mechanism instituted during the special campaign will be continued and Ministries/ Departments will be monitored against pendency on monthly basis.

**A two-day Regional Conferences on “Strengthening of State Institutes of Public Administration** was organized in Lucknow on November 11-12, 2021 . About 95 Delegates from Central Training Institutes and State Institutes of Public Administration including Lal Bahadur Shastri National Academy of Administration participated in the Conference. The conference was jointly inaugurated by the Honble Chief Minister of Uttar Pradesh and MoS for Ministry of Personnel , Public Grievances.

**Other activities**

DARPG celebrated the Constitution Day on 26.11.2021 by organizing Webinar on "Kartavya and Jan Bhagidari under Indian Constitution". Dr. Indrajeet Prasad Gautam, Member, Lokpal, Shri Neeraj Kumar Gupta, Information Commissioner, Central Information Commission and Prof. Ramesh Arora, Chairman, Management Development Academy, Jaipur were the lead speakers.
