This is a proposal of DARPG seeking concurrence of IFD for release of 3rd installment of Rs. 50.00 lakh (i.e. 25% of 200 lakh) towards implementation of the project 'Upgradation of e-Office Arunachal Pradesh from version 5.6.05 to version 7.x' under the State Collaboration Initiative (SCI) Scheme.

2. It is pertinent to mention here that the project was recommended by the Screening Committee in its meeting held on 20.09.2022 with approved cost of the project as Rs. 200 lakh with timeline of 05 years and the proposal was concurred by IFD (p-8/c). Accordingly, 1st (p-15/c) and 2nd installment (p-54/c) with concurrence of IFD. Now, Govt. of Arunachal Pradesh has furnished UC vide letter dated 08.01.2025 alongwith expenditure statement and progress report of the project stating that the entire amount has been utilized. The details of the status of e-office implementation in Arunachal Pradesh may be seen vide para 4, note#36.

3. The proposal of DARPG has been examined and it has been observed that the proposed expenditure would be met from GIA General under SCI initiative.


