

# HARYANA'S PATH TO

## **GOOD GOVERNANCE**

Government of Haryana enacted Haryana Right to Service Act, 2014, notifying timelines for public services to act as benchmark for the functioning of public functionaries.



THE ACT aims to provide for the delivery of services and benefits of schemes to ELIGIBLE PERSONS within THE NOTIFIED TIME LIMITS and for matters connected therewith and incidental thereto.




- ELIGIBLE PERSON
- Includes Legal entities



- NOTIFIED TIME LIMIT
  - Starts as soon as a DULY FILLED APPLICATION is received by the designated officer or a subordinate authorized to received the same
  - Implies the number of WORKING DAYS within which the service must be delivered after the receipt of the application

Timelines notified for delivery of public services act as benchmark for the functioning of public functionaries. At present, 431 services and 132 schemes (Total-573) are notified under the Act. Some of the timelines are as under








In the event of contravention of provisions of the Act, a three step appellate mechanism was also set up with the establishment of Haryana Right to Service Commission.





However, even after seven years of enactment, the implementation of the Act suffered the grunt of lack of awareness among the citizens.



Although RTS Act delineated a mechanism to file appeal in case of non/timely delivery or rejection of services, the provisions were not used by the citizens which is evident from the fact that **only 7 appeals were filed in 7 years from 2014 till** 

June, 2021



AAS was launched by Hon'ble CM Haryana on 1<sup>st</sup> September, 2021.








The uniqueness of AAS lies in the fact that it essentially entails State going into litigation against its own delinquent officers at a mass scale for not meeting the benchmarks set. Almost 2 lakh appeals have been raised over AAS, with over 50% already having been resolved.
