This is a proposal of DARPG seeking concurrence of IFD for releasing Rs. 50,00,000/- as 4th and final installment towards the project "eLARRM"- Digitization and Online processing Monitoring and Management of Land Acquisition, Rehabilitation and Resettlement.

2. It is pertinent to mention that the proposal of DARG for release of 4th installment of Rs. 50.00 lakh was last examined by IFD vide note#100 and SMD was advised to reconcile the proposals submitted in the CFY on which concurrence has already been obtained and under submission for a better quality on net availability of fund for fresh sanctions. Now, SMD vide note#108 has re-submitted the proposal that at present sufficient fund is available under the Head 42.01.31 Grant-in-aid General.

3. The proposal of DARPG has been examined and it has been observed that an allocation of Rs. 17.00 cr has been made in the BE under the head Grant-in-General. Accordingly, IFD may concur with the proposal of DARPG for releasing Rs. 50,00,000/- as 4th and final installment towards the project "eLARRM"- Digitization and Online processing Monitoring and Management of Land Acquisition, Rehabilitation and Resettlement subject to the approval of the competent authority. SMD is also advised to maintain an excel sheet to keep a track of sanctions issued in lieu of the concurrence obtained by IFD.
